Canterbury Oast Trust Fundraising Privacy Notice

This privacy notice sets out how Canterbury Oast Trust (COT) fundraising uses and protects your information.

How do we collect your information?

When you support COT, eg make a donation, volunteer, become a member, attend an event or visit the RBC, we may ask you to provide certain personal details including your name, address and contact details such as your telephone number and email address.

How do we store your information?

With your consent we will keep your details on our secure database, which is compliant with data protection regulations, together with appropriate and relevant communication, eg notes, emails and discussions. We may keep this data for a minimum of 7 years, and will contact you every three years to ensure our records are accurate, however should you change your mind we will stop communicating with you at any time at your request.

Only COT authorised users of our CRM system will have access to your personal information.

How do we use your information?

With your consent we will use your details, and the details of how you have supported us, such as the area you live or events you have previously attended, in order to send you relevant and appropriate information about our charity, by mail or email. We may also use your donation information for internal reporting and analysis purposes within COT. Who do we share your information with?

We will never sell or share your information outside of the COT organisation, which includes the Rare Breeds Centre, unless relevant to your donation to us, for example in making our Gift Aid claim to the Government. We will never purchase personal information from any other organisation, if required, we would only ever use information available to us in the public domain.
