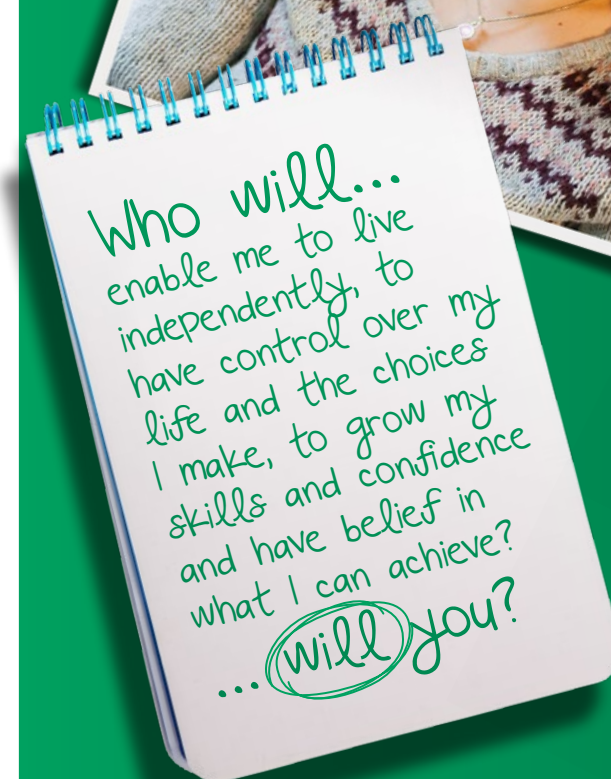

Do I need a Will?

Your Will is a very important document and writing it can be an uplifting experience. It's your chance to continue to help and provide for your loved ones and to keep supporting the causes you care about after you've gone.

Here are some options for gifting a legacy to Canterbury Oast Trust

- **Residuary** is when you give all or a percentage of the residue or balance of the value of your estate.
- **Pecuniary** is a specified sum of money, decided when your Will or Codicil is written.
- **Specific** is when a particular item of value is left to Canterbury Oast Trust.

We encourage you to consult family and take legal advice as to which option might suit you.

If you have already made your Will and now wish to leave a gift to Canterbury Oast Trust, please speak with your solicitor about a Codicil.



From 5 April 2012, the usual 40% rate of inheritance tax was **reduced to 36% if at least 10% of an individual's taxable estate is left to charity** on their death. The rules applicable to this relief are complicated so please seek advice from a solicitor.
